III. New Business:

- b. JMP Preschool Grants: Eight preschools submitted grant requests for \$3,000 thus far. Board reviewed all applications. There was a question from the board regarding the Grinnell Early Learning Center grant. Blanchard will contact Valerie Steinbach to clarify the grant request. Motion by Wendl to approve seven preschool quality improvement grants at \$3,000 per preschool. Seconded by Cameron. Motion passed unanimously. Smith abstained from the vote.
- c. FY23 Proposed Budget: Board reviewed tentative line items and funding amounts for the FY23 budget. JMP funding is projected to decrease by approximately \$67,000. No final appropriation has been made by the legislature at the time of the meeting. Board will consider the budget as presented and vote final approval at the May meeting so contracts can be executed.

- IV. Other: Board discussed meeting in person. It was decided the board would meeting in person for the June board meeting. Meeting will likely be held in Newton.
